

## Hygiene concept for youth camps

The following hygiene measures must be observed for all youth camps (for the stays in other federal States, different regulations may apply):

1) The following measures ensure the applicable physical distance and contact restrictions:

a. A physical distance of at least 1.5 meters per person must be ensured, unless the applicable Corona Control Regulation provides otherwise. Measures must be taken to control access and maintain the physical distance requirement, including appropriately signposted path concepts.

b. If increased aerosol emissions are to be expected due to the type of sporting activity, a minimum distance of 3.0 m must be maintained.

2. Organization of youth camps:

a. Contact data of all persons (Name, first name, address, telephone number) as well as the duration of the visit are to be documented after obtaining consent to enable contact person tracking and are to be kept by the operator for a period of 1 month starting on the day of the visit and subsequently destroyed in compliance with the DSGVO. Processing of the data for other purposes is not permitted.

b. All persons will be informed about the protection and hygiene regulations before participation and immediately at the beginning of the activity. Participants in a youth camp must provide confirmation from their legal guardians or a self-declaration that they are healthy, adhere to the

necessary physical distance and contact restrictions and have not knowingly had any contact with persons with Covid 19 infection in the 14 days before the start of the youth camp.

c. On arrival, the relevant hygiene concepts for coach travel must be observed, as far as they are applicable.

d. The youth camps should - as far as possible - be divided into small-supervised groups with a maximum of 25 persons (including support staff). Mixing of children and young people from other small groups in the accommodation facility is to be avoided.

e. Individual contacts between the permanently supervised small groups are possible, subject to compliance with the general hygiene and physical distance regulations.

f. Common rooms, in particular showers and changing rooms, are exclusively for use by individuals or family members of a household.

g. Catering may be provided in accordance with the hygiene regulations for catering trade.

h. In the case of youth camps with overnight accommodation, the requirements for accommodation establishments must also be observed, in particular § 8 Para. 6 of the 9th CoBeLVO. The accommodation providers are responsible.

### 3. Individual personal measures

- a. Persons with recognizable symptoms of respiratory tract infection shall be denied access.
- b. The applicable protective measures and rules of conduct (including general rules of infection protection such as "sneezing etiquette", classification of cold symptoms, etc.) shall be indicated by appropriate signs.
- c. All persons shall wear a mouth-nose cover, in accordance with the Corona Control Regulation in the up-to-date version.
- d. It is not permitted to sign-out items to others unless they can be disinfected after use.

#### 4. Measures related to the facility

- a. Hand disinfectant, liquid soap and disposable towels must be provided in sanitary, common and break rooms.
- b. Specific measures shall be taken to minimize the exposure of rooms to aerosols. All rooms shall be sufficiently ventilated.
- c. For group offers within the framework of indoor youth camp activities, the hygiene concept for indoor events shall apply. d. The hygiene concept for outdoor events in the context of the youth camps applies to outdoor events during the youth camp.

e. For sports and other recreational activities, the respective hygiene concept for these kind of activities shall apply.

## 5. General Principles:

a. An authorized person shall be appointed on site to ensure compliance with the regulations.

b. Persons who are not prepared to comply with the following rules are to be denied access or stay within the scope of the domiciliary right.

c. In addition, the responsible authority may, in justified individual cases and on application, allow exceptions or issue other hygiene requirements, provided that a specification according to CoBeLVO is not mandatory, the level of protection appears comparable, and the purpose of CoBeLVO is observed.
