

## **Hygiene Concept pertaining to Indoor Events with simultaneous Presence of up to 250 Participants**

This applies to in-door group gatherings with up to 250 participants at the same time.

At all events, the following hygiene measures must be observed:

1. The provisions for physical distancing and contract restrictions will be assured by the following measures:
  - a. Access restrictions are to assure that there will be no more than one person per each 5 square meter per sales or visitor area. The provision for physical distancing and personnel limitation (one person per 5 square meter) must be observed in the building except in cases where every visitor has their firm assigned place. In this case compliance with physical distancing prevails.
  - b. The minimum physical distance of 1.5 meter must be assured for every person as far as the applicable Corona Abatement Ordinance does not provide for another rule. Measures to manage access and to comply with physical distancing must be abided by; this includes walk way concepts indicated by adequate signs. One-way personnel traffic should be established to the extent possible. Waiting areas (e.g. in front of sales outlets and toilets) also have to show markers for physical distancing.

### 2. Organization and Implementation

- a. The organizer/owner is required to collect contact data of all persons entering the premise (name, first name, address, telephone number) as well as log the time of entry and check-out of the person. These data are to be kept for a period of one month starting with the day of the visit and will be destroyed in accordance with DSGVO [German General Data Protection Regulation]. These data must not be used for other

purposes.

- b. Use of sanitary installation is admissible under observance of applicable protective measures.
- c. Food and drink may be served in accordance with the regulations for the catering trade.
- d. Information and sales stands must be at least 3 m apart.

3. Individual measures:

- a. Persons with visible symptoms of a respiratory infection will not be granted access.
- b. All persons must disinfect or wash their hands upon entry of the premise. Suitable washing facilities or disinfectant dispensers must be provided by the organizer.
- c. The applicable protective measures and rules of conduct (including general rules of protection from infection such as "sneezing etiquette", evaluation of cold symptoms, etc.) must be indicated by appropriate signs.
- d. As far as required by the latest version of the Corona Abatement Ordinance, visitors and employees are to wear a mouth-nose-covering.
- e. Cashiers can be protected by a separating glass. Personnel who are protected by a separating glass or other appropriate protective measures shall be exempt from wearing the obligatory mouth-nose-covering.

- f. The hygiene concept for indoor and outdoor sports must be applied for exercise.
  - g. For activities associated with musical performances, the music hygiene concept must be applied.
  - h. Renting objects is not permitted if these cannot be disinfected after use.
4. Facility-related measures:
- a. Hand disinfectants, liquid soap and disposable towels must be available in sanitary, common and break rooms. Rooms must be cleaned regularly.
  - b. Specific measures must be taken to minimize the impact of aerosols in rooms. All rooms must be adequately ventilated.
5. Generally applicable:
- a. The organizer must appoint a person on site to ensure compliance with the regulations.
  - b. Persons who are not willing to comply with these rules are to be denied access or stay in accordance with the home order.
  - c. For rehearsals and performances, the current version of the guidance of the institution for statutory accident insurance and prevention in the administrative sector (VBG) – Hamburg “SARS-Cov-2-Occupational Safety Standards – recommendation for stages and studio rehearsal operations” can be applied.

- d. Furthermore, the competent authority may, in justified individual cases and upon request, issue special permits or impose other hygiene requirements, provided that a regulation pursuant to the Corona Ordinance CoBeLVO is not mandatory, the level of protection appears comparable and the purpose of CoBeLVO is complied with.
