¹ **All Travelers Entering/Returning to Germany must complete their registration** at <http://www.einreiseanmeldung.de/#> and upload their vaccine or recovery status, if applicable.

² **Official Travel Exception:** US service members and civilian personnel conducting official travel do not have a host nation requirement to register and are not required to quarantine if arriving from a high incidence area. The exceptions do NOT apply to virus variant areas.

³ **Full vaccination:** 14 days following the final COVID-19 vaccine immunization

⁴ **Recovery:** diagnosed with COVID-19 via PCR test and currently more than 28 days but less than 180 days from the positive test date

⁵ **Exceptions to digital registration for those coming from virus variant areas:**

Only passed through a risk area without a stopover;

Only passing through Germany and will be leaving the country by the quickest route to complete their transit;

Entering Germany in order to be hospitalized for COVID-19 and cannot be treated abroad; or Spent less than 24 hours in a risk area or will spend less than 24 hours in Germany under the border traffic regime.

⁶ **Exception to test requirement for those coming from virus variant areas:** cross-border commuters with the proviso that they must provide proof of testing at least twice a week.

⁷ **Exceptions to isolation requirement for those coming from virus variant areas:** same exceptions as in note 5 above.

⁸ **Exceptions to digital registration for those coming from high incidence areas:** all exceptions in note 5 above plus service members and civilian employees of the US Forces on official travel.

⁹ **Exceptions to test requirement for those coming from high incidence areas:**

Only passed through a risk area without a stopover;

Only passing through Germany and will be leaving the country by the quickest route to complete their transit; or

Cross-border commuters with the proviso that they must provide proof of testing at least twice a week.

¹⁰ **Exceptions to the isolation requirement for those coming from high incidence areas:** same exceptions as in notes 5 and 7 above.
