Hygiene concept pertaining to extracurricular educational programs, vocational training and continuing education

The following hygiene measures are to be adhered to when carrying out activities relative to the areas mentioned above:

- 1. The current provisions for physical distancing, mask wear and contract restrictions will be assured by the following measures:
 - a. The simultaneous presence of a teacher and one student/participant is permitted for most offerings. Larger groups are only permitted to partake in these educational offerings remotely (virtually). Exceptions are provided for in the respective valid ordinance.
 - b. The participants are required to maintain a distance of at least 1.5 meters per person, unless the applicable Corona Control Ordinance provides otherwise. Access managing and distance maintaining measures are to be provided for, to include walkway concepts indicated by adequate signs. Single direction walkways are to be implemented to the extent possible. Waiting areas (e.g. in front of stands and toilet facilities) are also to show markers for physical distancing.
 - c. A medical face mask (surgical mask) or a mask of the KN95/N95 or FFP2 standard or comparable is to be worn indoors.

2. Organization and implementation

- a. The contact traceability of the persons attending must be ensured. The educational facility is required to collect contact data (last name, first name, address, and telephone number), ensuring that the person can be reached, and log the date and time of entry and check-out in compliance with the data protection regulations. The data is to be kept for a period of one month; after expiry of the retention period, it is to be deleted without delay.
- b. Catering is subject to the provisions pertaining to gastronomy.
- c. Use of sanitary installation is admissible under observance of applicable protective measures.

d. Sports and physical training activities offered by public and private facilities other than public or vocational schools are subject to § 10 of the Ordinance accordingly.

e. In-person extracurricular music lessons are permitted with simultaneous presence of a teacher and one student. This does not apply to activities associated with increased aerosol emissions, such as singing or wind instrument lessons. Such classes must be held outdoors. The distance requirement IAW § 1 Para. 2 Sentence 1 and the mask requirement IAW § 1 Para. 3 Sentence as well as the contact tracing requirement IAW § 1 Para. 8 Sentence 1 apply. Extracurricular music and art lessons in groups of up to 20 children aged 14 and under together with one teacher are permitted outdoors.

3. Individual measures:

- a. Access shall not be granted to persons showing visible symptoms of a respiratory infection.
- b. Each person is to wear a medical face mask (surgical mask) or a mask of the KN95/N95 or FFP2 standard or comparable during their stay at the educational facility. The mask requirement also applies when seated.
- c. If compliance with the mask requirement is not feasible or possible, an underlying medical certificate must be submitted, showing clearly at least the basis for the medical diagnosis as well as the reasons, why the wearing of a mask represents an unreasonable burden in the specific case.
- d. All persons must disinfect or wash their hands upon entering the event.

 Suitable washing facilities or disinfection dispensers are to be provided.
- e. The applicable protective measures and rules of conduct (such as general rules for preventing infections, e.g. "sneezing etiquette", identification of cold symptoms, etc.) are to be indicated by adequate signs.

f. Personnel can be protected by a safety screen. Personnel shielded by a safety screen or other adequate protective measures are exempted from wearing any mouth and nose protection.

g. Renting objects is not permitted if these cannot be disinfected after use.

4. Facility-related measures:

- a. Hand disinfectant, liquid soap and disposable towels must be available in sanitary, day and break rooms. Rooms are to be cleaned regularly.
- b. Specific measures are to be taken to minimize the aerosol impact in rooms. All rooms are to be aired properly.

5. Generelly applicable:

- a. A responsible person must be appointed on site to ensure compliance with the regulations.
- b. Individuals not prepared to comply with these regulations are to be denied access in accordance with the facility rules.
- c. Reference is made to the SARS-CoV2 occupational health and safety standard of the Federal Ministry of Labor and Social Affairs regarding the occupational health and safety of employees.
- d. In deviation from the above, the ministry responsible for the relevant field of education can permit exceptions in consultation with the ministry responsible for health affairs, in particular, if the educational services are of particular importance to the long-term safeguarding of public safety and order and to the maintenance of proper operation of public administration, medical care or pandemic management, or to tutoring and/or remedial education for schoolchildren, provided that the educational institutions maintain adequate hygiene concepts.
