

Command Civilian Award for Valor (CCAV)

Purpose: To recognize unusual courage or competence in an emergency, either on or off the job, but beyond the call of duty that warrants special recognition, but does not rise to the level of an AFCAV.

Eligibility: The award is given to any Air Force civilian employee who demonstrates courage or competence in assisting others in an emergency, such as supervising an orderly exit from a building during a fire, keeping others calm, or executing the proper course of action in an emergency.

Process: Supervisor prepares AF Form 1768, *Staff Summary Sheet*, or an electronic Staff Summary Sheet (eSSS) which includes employee's full name, grade, duty title, organization, social security number, period covered, and any other information considered appropriate or useful.

AF Form 1768 should have attached a *draft citation*, written in third person, with job designation, organization, period covered, and statement of achievement, may not exceed 9 lines and cannot contain more than 120 characters per line.

The *justification* should be typed on bond paper, in bullet format, and should not exceed one page.

Package must be submitted electronically to 86fss.civ-awards@us.af.mil

An honorarium in an amount up to \$500 may accompany this award at the discretion of the MAJCOM Commander or designate representative. If an honorarium will accompany the award, specify the amount and the name and title of the approving official on the AF Form 1768.

There is no limit on the number that may be awarded. Award will be documented in the civilian data system, the SF-50 filed in the Official Personnel Folder and a copy of the AF Form 1768 and justification will be filed in the Employee Performance File (EPF) help by the supervisor.

Award Description: A sterling silver medal bearing the Air Force thunderbolt on an equilateral triangle surmounted by the Air Force eagle perched on a scroll inscribed “Valor” within an olive wreath and a light blue silk ribbon with four yellow stripes and one red stripe in the center. Also, a sterling silver lapel emblem, ribbon rosette, AF Form 1307, *Command Civilian Award for Valor Certificate*, and up to \$500 optional honorarium accompany this award.
