

Foreword

Dear fellow citizens,

The coronavirus pandemic that started last year has changed all our lives a great deal. It has presented us with new challenges in many areas – and this also applies to waste management.

Furthermore, we can no longer shield ourselves from inflation or the low prices obtained for recyclable materials on the world market. Because of these, we are losing great amounts of income from the monetization of wastepaper, while logistics costs have risen considerably.

Consequently, from 2021 there will be a moderate increase in waste disposal fees. The fees have remained almost the same since 2013. Unfortunately however, this adjustment can no longer be avoided, because the county must cover its costs with these fees. This problem is not specific to the county but affects all waste disposal companies equally, both locally and nationally.

An important objective that plays a significant role in environmental policy across the country is the use of the brown can, which prevents valuable organic waste being mixed in with non-recyclable waste. According to the results of the latest nationwide household waste analysis¹, non-recyclable waste still contains around 39% organic waste, which is burned unnecessarily instead of being recycled. Please support this objective! For organic waste, and especially for waste that you do not wish to compost, kindly use the brown can [for further information see pages 7ff].

If we all do our bit, we can achieve a great deal and we can ensure together that fees remain the same. The more carefully we separate our waste, the cheaper the disposal. This will also help protect valuable resources and our environment.

Rather, the collected waste streams are sent for separation and recycling at large recycling facilities, energy recovery, and/or incineration plants.

Help represent our military community positively in regards to environmental impacts by reducing our waste footprint. We owe it to our planet to take care of our homes and environments.

Thank you for taking responsibility for keeping our environment clean, safe and healthy. We are all proud to live and work here – let's show it.

Non-recyclable waste

Non-recyclable waste

Non-recyclable waste (black can) is picked up every other week, alternating with biodegradable waste. Please place the black can with the lid closed at the curb before 6 a.m. on the collection day. Cans that are overfilled will not be emptied.

After registering with the resident registration office, every household automatically receives a black can.

For persons who are not required to register – generally members of the armed forces – **the home owner must notify the waste management office of the county administration** (in writing or by phone).

The minimum can size for non-recyclable waste depends on the number of household members. If the allocated can is not sufficient for a household, the county administration will provide a larger can upon written request of the home owner.

Minimum volume of cans for non-recyclable waste depending on the household size:

Household size	Required minimum volume per 2 weeks
1 person	30 liters
2 persons	55 liters
3 persons	75 liters
4 persons	90 liters
5 persons	105 liters
6 persons	120 liters
each additional household member	15 additional liters pp.
Businesses	30 liters minimum

WASTE FEES (normal and reduced)

The waste disposal fees are yearly charges depending on the can size for non-recyclable waste.

If you use all the organic waste of your household for composting in your garden, you can cancel the can for biodegradable waste. As a consequence, you will be granted a reduction in waste disposal fees.

JOINT DISPOSAL

It is possible to request **joint disposal**, i.e. two or more households living on the same lot share a can for non-recyclable waste. For this option all households participating in the joint disposal must either compost their organic waste or use a brown can. Joint disposal of private households and businesses is possible as well, provided that the minimum can size for non-recyclable waste (30 liters for the business) is respected.

When determining the can size for joint disposal, the minimum volumes for non-recyclable waste of each participating household or business will be totaled.

Calculation example for joint disposal

Households	Min. volume of non-recyclable waste per 2 weeks	Number and size of cans for joint disposal
1 person + 2 persons	30 liters + 55 liters = 85 liters	 90 liters
2 persons + 3 persons + 1 person	55 liters + 75 liters + 30 liters = 160 liters	 60 +  120 liters
1 person + 1 business	30 liters + 30 liters = 60 liters	 60 liters

Please fill in the **specific application form to request joint disposal**. The form is available at the waste management office of the county administration or your municipal administration. You can also download and print the form ["Entsorgungsverbund"] from our website at <https://www.kaiserslautern-kreis.de/buergerservice/formular-pool.html> (in German only).

If you request to change the size of your black can, you will be charged a one-time fee of 30.60 €.

BAGS FOR NON-RECYCLABLE WASTE

In cases where your black can is not sufficient, you can buy specific **bags for your non-recyclable waste (3.89 € each)** at your municipal administration or the Kaiserslautern county administration.

Please place the bags at the curb on the collection day together with the black can.

Please note: Waste bags have to be **tyed up** properly for collection. Open bags will not be picked up.

Waste disposal fees include the following services:

- Supply and emptying of cans for non-recyclable, biodegradable and paper waste
- Disposal of hazardous waste at the hazardous waste truck ("Umweltmobil") and at the hazardous waste storage of the ZAK recycling center
- Battery collection points
- Bulk waste pickup
- Disposal and pickup of electrical appliances
- Collection points for garden clippings
- Free refuse of recyclable material in household quantities at the recycling centers Kindsbach and Kapiteltal

Non-recyclable waste

WHAT TO DO WHEN RELOCATING

- Please contact your municipal administration as soon as possible. Make sure to inform the Kaiserslautern county administration in writing if the ownership of your home changes. You will receive the required waste cans automatically.
- **Do not take waste cans with you when you move!** Each can has an identification number assigned to a specific lot.
- While waiting for your cans, you may use the bags for non-recyclable waste available at the Kaiserslautern county administration or your municipal administration (3.89 € each). The first waste disposal fee will be charged for the month **following** the supply of the cans.
- Each household receives their own can for non-recyclable waste. **If you intend to make use of joint disposal, kindly notify the county administration in writing at your earliest convenience.**
- Please also inform the county administration in case persons with different last names live in the same household. Otherwise each person will be considered a separate household and receive their own waste cans.

WHAT GOES IN THE BLACK CAN?

Expired medication

Toiletries
Cotton rounds and stabs, tissues, wipes, tampons, sanitary pads, diapers, toothbrushes, dental floss, etc.

Household waste

Soiled paper and paper towels, dust bags, toilet brushes, rinsing and cleaning sponges or rags, small quantities of dishes, cutlery, pots, bowls, candlesticks, drinking glasses, coal and briquette ash, wallpaper, cigarette butts, sweepings, cat or other pet litter, pet excrements, etc.

Textiles

Soiled clothing, torn shoes, handbags, hats, belts, etc.

WHAT DOES NOT GO IN THE BLACK CAN?

Plastic packaging without content
(see "Yellow bag")

Organic waste
(see "Biodegradable waste") including food leftovers and citrus peels

Construction debris
Sand, stones, bricks, timber, etc.

Hazardous waste
(see "Hazardous waste") such as batteries, halogen lamps, energy saving bulbs, small electric appliances, asbestos, etc.

Biodegradable waste

Biodegradable waste (brown can) will be picked up every other week, alternating with non-recyclable waste. Please place the brown can with the lid closed at the curb before 6 a.m. on the collection day. Cans that are overfilled will not be emptied.

THE BROWN CAN

In Kaiserslautern county, organic waste is disposed of in the brown can and recovered separately.

Unless you have requested home composting (see page 9), you will be supplied with a brown can automatically, together with the black can.

The fee for the brown can depends on the size of the black can: A household with 3-4 members with a 90-liter black can, for example, will be charged 27.60 € per year for biodegradable waste (see page 4 for individual fees).

The size of your brown can also depends on the size of the black can allocated to your household or home. For private households the brown can is at least as large as the black can, with the option of doubling the size on request.

As opposed to private households, for businesses the maximum brown can size included in the waste disposal fee is the size of the black can.

The table below gives an overview of new brown can sizes. The minimum size is 120 liters.

Volume of black can	Standard volume of brown can	Maximum volume of brown can (upon request)
60 liters	120 liters	120 liters*
90 liters	120 liters	240 liters*
120 liters	120 liters	240 liters
240 liters	240 liters	2 x 240 liters

* When using a 60- or 90-liter black can, the volume of the brown can (that is usually not more than twice the size of the black can) can be increased to 240 liters upon written request (please specify the exact reasons).

Derogations may be granted in duly justified cases.

Should the maximum brown can size not be sufficient for your biodegradable waste, you have the option to order an extra can. Additional yearly fees of 76.08 € for a 120-liter can or 152.04 € for a 240-liter can will apply.

The relevant form is available at your municipal administration or on our website in the section "Abfallwirtschaft/Anträge Abfallwirtschaft" (in German only).

Please note: If the extra can is provided after the regular waste containers have been supplied, you will be charged a one-time fee of 30.60 €.

Biodegradable waste

WHAT GOES IN THE BROWN CAN?

Garden waste

Leaves, grass clippings, plants, potting soil

Kitchen waste

Coffee/tea filters, paper towels, egg shells, banana and citrus peel, food leftovers including meat and fish, cold cuts, bones, bread, pastries, cheese, vegetables, fruit, etc.

Other organic waste

Potted plants, nut shells, small amounts of wood ash, feathers, newspaper for wrapping leftovers, etc.

Do not pack biodegradable waste in plastic bags!

WHAT DOES NOT GO IN THE BROWN CAN?

Packaging

made of plastic, metal, composite materials, glass, etc.

Non-recyclable waste

such as diapers, cigarette butts, leather, sweepings, dust bags, hygiene products, pet excrements, cat and other pet litter, medication, etc.

Construction debris

Sand, stones, bricks, timber, etc.

Hazardous waste

To avoid unpleasant smells and maggots in the brown can:

- Wrap organic kitchen waste in newspaper.
- Keep the can in a shady place with the lid closed!
- Put the waste in compostable paper bags for biodegradable-waste [available in stores].

Dumping banned waste in the brown can is an administrative offense that may be subject to a fine!

If your can contains banned waste, it won't be emptied and a red label will be attached to it. In this case you have the following options:

- Sort out the waste that is not biodegradable and place the can at the curb on the next collection day.
- Dispose of the mixed waste in your container for non-recyclable waste or in one of the gray waste bags of the Kaiserslautern county [see page 5].



Biodegradable waste

If all your organic waste is composted and used in your garden, you don't need a brown can. In this case the home owner may apply for a reduction of waste disposal fees for home composters. However, we recommend using the brown can to dispose of problematic leftovers such as fish, meat and bones or clippings with a plant disease. With home composting you only save a small amount of money. For a household with 3-4 members it is 27.60 € per year [see waste fee overview on page 4].

HOME COMPOSTING

Please note: To be admitted for home composting, i.e. the re-use of organic waste directly in your own garden, the following requirements must be met:

- correct and safe composting procedures
- composting of the full amount of organic waste
- sufficient garden space [approximately 30 m² per person] to use the entire compost output
- existence of a demonstrable composter with decomposing material

An on-site verification of the above requirements is possible. Violations are an administrative offense that may be subject to a fine.

The application for home composting must be renewed whenever the tenant or owner changes. Otherwise a brown can will be supplied automatically.

Application forms are available at your municipal administration.

A written notice is required if you intend to stop composting. Extra supply or returning a container will be charged with a one-time fee of 30.60 €.

Garden clippings [hedges, branches, grass] can be dumped at the organic waste collection point in your community.

Yellow bag

The yellow bags for re-usable materials will be picked up at the curb together with non-recyclable waste. Please place the tied-up bag next to the black can before 6 a.m. on the collection day.

THINGS TO KNOW ABOUT THE YELLOW BAG

- Put items in the bag one by one, not packed in plastic liners.
- Make sure that different materials do not stick together.
- Remove the aluminum foil from plastic cups.
- Only collect empty packaging and wrappings. Packaging containing pollutant-free leftovers are non-recyclable waste.
- Packaging containing residues of harmful substances must be taken to the hazardous waste truck.

BASIC DISTRIBUTION

A basic quantity of yellow bags is distributed at the end of each year (usually in November). Each household receives 2 rolls (60 bags in total).

In case you haven't received any yellow bags by the end of the distribution period, please call the responsible company Jakob Becker Entsorgungs-GmbH, **toll-free hotline: 0800 / 7236661**. [The waste management office of the county administration is not responsible for complaints.]

The basic amount of 60 yellow bags should be sufficient to meet the annual demand.

ORDERING ADDITIONAL YELLOW BAGS

ATTENTION

It is not possible to order yellow bags by phone!

Please note: Yellow bags are not distributed and collected on behalf of the Kaiserslautern county administration. These services are not included in the waste disposal fees.

The yellow bag is being financed exclusively by the dual systems in Germany which receive a fixed monetary amount for each individual packaging sold.

Yellow bag

WHAT GOES IN THE YELLOW BAG?

Plastics

Foils: e.g. plastic packaging, bags, liners, cling film
Plastic bottles: e.g. for detergents, toiletry, beverages
Cups: e.g. for margarine or yogurt [please remove aluminum lids]
Foamed material: clean styrofoam packaging, foamed wrappings e.g. for fruits or vegetables

Metals

Packaging made of metals, empty spray cans, food and beverage cans, aluminum [e.g. lids of yogurt cups, foil], bottle caps

Composite materials

Packaging made of composites, beverage cartons e.g. for juice or milk, coffee packaging, vacuum packs

WHAT DOES NOT GO IN THE YELLOW BAG?

- Glass, paper, cardboard
- Packaging with [residual] contents e.g. spoiled food
- Foamed materials e.g. mattresses, chair cushions
- Records, cassettes, CDs/DVDs
- Plastic pipes
- Insulating foams
- Bicycle tires, water hoses
- Pieces of carpet flooring and wallpaper
- Plastic items or furniture, e.g. chairs, laundry baskets, etc.
- Products made of [synthetic] leather
- Insulating material [styrofoam, polystyrene]
- Plastic household items and toys, e.g. bowls, buckets, ride-on toys, toilet brushes

ATTENTION

The yellow bags are for packaging made out of plastic, metal or composite materials only. Any kind of misuse, e.g. as bag for non-recyclable waste or for the collection of used clothes, is prohibited and may be subject to a fine!

For further information concerning the yellow bag please see the website of the dual systems initiative <https://www.muelltrennung-wirkt.de/en/> [waste separation works]. The initiative publishes the services required in relation to yellow bags in calls for tenders and engages bidding companies accordingly. The county does not have any influence on this procedure.

Should you have any **complaint** because your yellow bags have **not been collected**, please call **06303 / 804-191**.

Waste paper

The blue can for waste paper is emptied every 4 weeks. Please see the schedules for your community and place the can with the lid closed at the curb before 6 a.m. on the collection day. Cans that are overfilled will not be emptied.

The blue cans used for the collection of waste paper in Kaiserslautern county have a volume of 240 liters. Usually each home will be assigned one can. If a larger volume is required for waste paper because of the number of persons or the existence of a business, additional 240-liter cans will be provided upon request.

In case a home requires more than four cans, it might be advisable to choose a 1,100-liter container (1.1 m³) for waste paper instead. The container is easier to handle than multiple cans and bulky cardboard can be dumped more conveniently. Unlike with 240-liter cans cardboard boxes do not have to be torn. They can simply be folded to fit into the container.

1,100-liter containers are emptied every 4 weeks on the same day as 240-liter paper cans [see attached schedule]. While 240-liter paper cans are free of charge, the company providing **1,100-liter** containers will charge the customer a monthly leasing fee of 9.00 € plus VAT.

As an alternative, customers can buy a standard 1,100-liter container and place it at the curb for waste collection. In this case, the Kaiserslautern county administration will empty the container free of charge.



If the can for paper waste is missing on your lot, if you have too many or too few cans or your can is damaged, please call the Kaiserslautern county administration [see page 32 "Allocation for households" for contacts]. We will arrange for the delivery, exchange or removal of cans.

1,100-liter containers must be ordered in writing [or by e-mail] because we need a billing address for the monthly leasing fee.

This will be communicated to the container provider.

Please get in touch with the waste management office if you are interested in a 1,100-liter container for waste paper.

In individual cases, e.g. after a relocation, the volume of your can or container might not be sufficient for your waste

paper. In such circumstances you can put your waste paper in cardboard boxes and place them next to your paper can on the collection day or take the excess waste to the recycling centers in Kindsbach or Kapiteltal.

ATTENTION

Paper cans and containers are for [clean] waste paper, cardboard and cartons only.

Any inappropriate use of the paper can or container is an administrative offense that may be subject to a fine.

Electronic scrap

SMALL ELECTRICAL APPLIANCES

Small electrical appliances include any electrically or battery powered device no larger than a coffee maker.

These appliances can be disposed of at the **hazardous waste truck** ("Umweltmobil") together with other problem waste. Alternatively, you can deposit them at the **recycling center in Kindsbach or at ZAK Kapiteltal**.

In addition, the union communities have **collection points with a container for small electrical appliances**.

Please note: The container slot is 28x18 cm to accommodate for small appliances only!

Examples:

- Small household appliances such as irons, hair dryers or curlers, electric toothbrushes, egg boilers, electric knives, hand mixers, toasters, water kettles, phones, clocks, pocket calculators, fire detectors, flashlights, etc.
- Small power tools such as drilling machines, cordless screwdrivers, grinders, glue guns, soldering irons, etc.
- Small home electronics such as remote controls, cell phones, smartphones, tablets, MP3 players, radios, headphones, speakers, keyboards, mouse devices, cables, etc.
- Small battery powered toys

ATTENTION
Do not dump energy-saving bulbs in the containers.
Remove batteries before dumping items.
Due to the high risk of fire, appliances with non-removable batteries may not be dumped in the containers.
Please take them to the ZAK center for hazardous waste.

LARGE ELECTRICAL APPLIANCES

Large electrical appliances, gas ranges and refrigeration units are collected upon request. Please notify us **by phone, fax, or e-mail** or via the Garbage Guide app. Kindly remember to indicate the type and number of appliances. You will be notified of the pickup date approx. 14 days after your request. Please place the appliances at the curb before 6 a.m. **on the collection day**.

Should the address where the appliances are to be picked up be different from your mail address, make sure to indicate this when requesting the service.

Please note: Alternatively, you can deposit any appliance, including refrigerating units, free of charge at the recycling center in Kindsbach or at ZAK Kapiteltal. By appointment only!

Tip: If you wish to donate second-hand clothes or shoes, you can have the staff take them along when they pick up your electrical appliances (see page 19 for details).

Bulk waste

Bulk waste will be collected upon request.

Each household registered for waste disposal has the opportunity to have bulk waste collected free of charge **twice a year** [(up to 5 m³ per pickup)]. Requests can be made by phone at 0631 / 7105-500 or -250, by fax at 0631 / 7105-449, by e-mail at sperrmuell@kaiserslautern-kreis.de or via **Garbage Guide app**. You will be notified of the pickup date in writing approx. 14 days after your request.

Bulk waste will be picked up by two different vehicles. One truck collects scrap wood, e.g. furniture or shelves, the other one is for non-recyclable bulk waste. **Please place your bulk waste at the curb before 6 a.m. on the collection day and separate wood from other items.**

The term bulk waste means all items that you would take along when moving and that are too large for the black can even when dismantled. [Exception: electronic appliances, see page 14].

BULK WASTE INCLUDES

- All household items (maximum edge length of 2 meters), such as
- Strollers
- Car seats / booster seats
- Bikes and scooters (non-electric)
- Garden furniture
- Furniture
- Large toys (non-electric)
- Large suitcases and boxes

- Wood, coal, and oil stoves [for the latter: please empty the tank completely, clean it and turn it up side down with the tank open; take tank residues and filters to the hazardous waste truck]
- Objects made of metal
- Water butts
- Mattresses
- Duvets and pillows
- Carpets / carpet floorings (rolled up)
- Drying racks, laundry baskets, etc.

NOT PICKED UP

- Car parts [except car seats] [see page 30]
- Balcony rails and canopies
- Electronic and gasoline mowers [see page 14+31]
- All kinds of electrical appliances [see page 14]
- Garden fences
- Household items that fit in the black can for non-recyclable waste
- Cardboard, paper, etc.
- Bags or boxes containing small parts [except metal parts]!
- Garden furniture treated with wood preservers
- Oil tanks / barrels
- Problem waste [e.g. paint buckets, oil cans]
- Building components, such as wood, ceiling lining, battens, bath screens, laminates, skirtings, stones, doors, windows, bathtubs, toilets, etc.

Household batteries

According to the Battery Regulation consumers are required to return used batteries, accumulators or button cells to the seller.

Non-removable batteries in electric appliances must be disposed of with the appliance [see page 14-15]!

Batteries can be returned to the dealer, taken to the hazardous waste truck, the ZAK center for hazardous waste in Kapiteltal or the recycling center in Kindsbach, the offices of the county administration in Lauterstraße 8, Kaiserslautern, or one of the following battery collection points.

When buying starter batteries [e.g. car batteries] consumers are charged a deposit, which is refunded upon return of the battery to the seller. In addition, the hazardous waste truck and the ZAK center for hazardous waste accept used starter batteries free of charge. A refund of deposits is **not** possible in this case.

Hazardous waste

Hazardous waste includes everything that is harmful for humans, animals and the environment. For reasons of public safety, it is not collected together with other waste. **Hazardous waste may under no circumstance be disposed of in household waste containers or toilets.**

Private households can drop small amounts of hazardous waste free of charge at the hazardous waste truck ["Umweltmobil"] or at the hazardous waste storage of the ZAK recycling center in Kaiserslautern Kapiteltal.

Please see the local press, the Garbage Guide app or our website to find out when the hazardous waste truck comes to your community and where the nearest stop is.

Please note: The hazardous waste truck does not accept commercial problem waste. Companies as well as small businesses must deliver their problem waste to the ZAK center for hazardous waste in Kapiteltal.

ATTENTION

Please make sure to hand hazardous waste and small electric appliances over to the staff of the hazardous waste truck. Do not leave any items unattended.

Any violation of this provision is a punishable offense.

Used clothing

As of mid-2013, the Kaiserslautern county waste management has collected and recycled second-hand clothes and shoes. With the assistance of the ZAK recycling center we cooperate with certified companies that guarantee a high-level re-use of the textiles. Every waste fee payer in the county benefits from the proceeds of this project.

You can find dedicated ZAK containers for used clothing and shoes at both recycling centers of the county as well as in Bruchmühlbach at Penny supermarket.

Alternatively, you can hand the textiles over to the staff of the hazardous waste truck or of the truck for electrical appliances on the collection day.

Please donate clean textiles and shoes (in pairs) packed in bags only.



Garden clippings

Many communities of the Kaiserslautern county offer collection points for garden waste. Private individuals who live in the county can dump organic waste that cannot be composted in the garden. This service is free of charge.

To ensure high-quality compost it is essential that collection points are not contaminated by other waste.

Please note: The following instructions for garden clippings:

YOU MAY DEPOSIT

- Grass clippings
- Leaves
- Plant parts
- Plants
- Clippings of trees and hedges
- Trunks and root stocks without soil, no more than 40 cm in diameter

YOU MAY NOT DEPOSIT

- Construction debris and stones
- Timber and furniture wood
- Wooden fences
- Soil
- Used clothing
- Windfalls
- Straw and hay from agricultural use
- Grave decorations
- Pet litter
- Non-recyclable waste
- Biodegradable waste, e.g. fruit, vegetables, food leftovers
- Root stocks and hedges exceeding 40 cm in diameter
- Manure from livestock
- Plant parts infested with *Cydalima perspectalis* [box tree moths]
- Potted plants with soil
- Rolled turf and sods

Please note: Many organic waste collection points have opening hours and are closed during the winter months. Feel free to ask your municipal administration for opening hours or visit <https://www.kaiserslautern-kreis.de/en/administration/waste-management.html>

ATTENTION

Dumping green waste from the commercial sector or by businesses is prohibited. Garden and park waste can be delivered to ZAK for a fee. Dumping garden clippings or banned waste outside the opening hours or outside the collection points or infringement of the provisions stipulated herein is an administrative offense that may be subject to a fine.

Chinaware, clay pots and vases, car screens/window panes, leaded glass, tumblers, heat-resistant glass [e.g. preserving jars]

Please put glass that is not white, brown or green, e.g. red or blue glass, into the container for green glass.

DROP-OFF HOURS

**Not on Sundays or German holidays!
It is not permitted to discard glass at other times.**

ATTENTION

Private households as well as businesses which are registered for waste disposal in Kaiserslautern county and have a can or container for non-recyclable waste can dump recyclable material here. The maximum monthly volume is 0.5 m³ per material.

ATTENTION

Waste exceeding the allowed volume will be rejected by the recycling center staff. Dumping recycling material at the recycling center outside the opening hours is prohibited and represents an administrative offense.

ACCEPTED WASTE

- Non-polluted **scrap wood** such as room doors, wall and ceiling lining – painted or glued, not treated with wood preservers
- Used **clothing and shoes** – not soiled or moldy
- **Recyclable construction debris** such as stones, concrete, soil, tiles, sanitary ceramics
- **Batteries** (no car batteries)
- **CDs/DVDs**
- **Plasterboards** without styrofoam
- **Glass bricks**
- **Electronic scrap**, electrical appliances including refrigerators and freezers
- **Energy-saving bulbs**, LEDs, halogen and fluorescent lamps
- **Window frames** made of metal or plastic (without panes)
- **Sheet glass** e.g. window panes
- **Natural corks** – no plastic corks
- **Bulky plastic items**, e.g. garden furniture or laundry baskets – no packaging material!
- **Laminate, parquet flooring**
- **Metals** – ferrous and nonferrous metals – no oil tanks!
- **Clean cardboard**, cartons, and paper – no wallpaper!
- **Polyurethane foam cans**
- **Clean plastic foils** – no agricultural foils, e.g. silage films!
- **Clean styrofoam** – no polystyrene
- **Bulk waste**: furniture, carpets, mattresses, etc.

Commercial waste

THE CATEGORY OF SO-CALLED COMMERCIAL MUNICIPAL WASTE INCLUDES:

Non-production related and solid waste that is generated on business premises, in commercial and industrial enterprises, in schools, kindergartens, hospitals, nursing homes, or by freelancers, such as office waste, heating residues, sweepings, etc. as well as production related waste that will not be fed into the production cycle.

If possible, companies can recycle their commercial municipal waste on their own responsibility.

Non-recyclable commercial municipal waste must be disposed of in the county's waste management system.

Depending on the quantity of non-recyclable waste generated, the company can choose one or more **black cans** with a volume 60 l, 90 l, 120 l, or 240 l that are emptied biweekly or a 4-wheel container with a volume of 1.1 m³, 3.3 m³, or 5.5 m³ that is emptied weekly or biweekly, at the buyer's option.

According to the information provided by the company, the size of cans or containers and the waste fee will be determined on the basis of population equivalents using the corresponding table in the Waste Management Statutes.

Without joint disposal the black can for non-recyclable waste has a minimum volume of 60 l.

A **can for biodegradable waste** is not necessary if this waste is composted or re-used externally [proof required]. In this case businesses will benefit from a reduced waste fee in the same way as private households do [see table on page 4]

If the business cannot substantiate that biodegradable waste is re-used, one or more brown cans will be provided depending on the black can size determined.

Contrary to private households, for businesses the brown can[s] may not be larger than the black can[s].

It is possible to request **joint disposal** for businesses and private households located on the same a lot [see pages 4-5].

DISPOSAL USING LARGE CONTAINERS

Large containers required for waste disposal have to be ordered by the person obliged to register for waste disposal, usually the property owner. Please make sure to use standard containers that are available for lease from a container provider or for sale from a container manufacturer.

The container leasing fee is not part of the waste disposal fee and will be invoiced directly by the provider.

Please note: When disposing of waste in skip or roll-off containers additional costs will be incurred according to the current ZAK Fee Statutes.

The county administration will send you a notification of charges where the fees for collection and disposal are listed separately. A bill of lading (weighing slip) issued by ZAK will be enclosed as proof.

What to do with ...

ANIMAL CARCASSES

According to the Waste Law animal carcasses are not considered waste and may not be disposed of in any of the containers provided by the Kaiserslautern county administration. Their disposal is subject to the Animal Carcass Disposal Law. ASBESTOS, FIBER CEMENT, ASBESTOS SHINGLES, FACADE PANELS

Avoid the generation of dust when treating items containing asbestos (e.g. sawing or breaking). The dust can cause cancer. Always have companies with a certificate of competence according to the Technical Rule for Hazardous Substances TRGS 519 remove asbestos products. Such products must be treated as hazardous waste. For more information please call the Kaiserslautern county administration at 0631/7105-408 or -505.

BATH TUBS

and shower trays of any material will not be collected together with bulk waste. Take these items to one of the recycling centers.

CAR BATTERIES

According to the Battery Regulation consumers are charged a deposit when buying starter batteries. The deposit is refunded when the battery is returned to the seller. Alternatively, you can dump car batteries free of charge at the hazardous waste truck or the ZAK hazardous waste storage (without refund of deposits).

CAR TIRES

Should be returned to the dealer. You can drop-off a maximum of 4 tires (with or without rims) free of charge at the ZAK recycling center.

CDS/DVDS

Can be dumped in the black can or the containers for plastic at the recycling centers.

DOORS AND DOORFRAMES

Can be dumped at the recycling centers [see pages 28-29].

DUVETS AND PILLOWS

Please offer duvets and pillows that are still useable to a charity organization. Alternatively, you can have them collected with bulk waste or take them to one of the recycling centers.

ELECTRIC STORAGE HEATINGS / NIGHT STORAGE HEATERS

These appliances can contain different amounts of loosely or firmly bound asbestos products. You can check with the waste management office of the Kaiserslautern county administration whether your appliance contains asbestos. Please indicate brand and product type. Phone: 0631/7105-408 or -505. Make sure to wrap unopened storage heatings in dust-proof film and hand them over to the ZAK recycling center staff, classified as electrical appliances. **Only specialized companies holding a certificate of competence according to TRGS 519 are permitted to dispose of storage heaters. Never open such appliances!** For more information on qualified companies please call the municipal craftsmen association ["Kreishandwerkerschaft"] at 0631/37122-0.

ENERGY-SAVING BULBS AND HALOGEN LAMPS

Are accepted by the hazardous waste truck, the ZAK hazardous waste storage and the Kindsbach recycling center.

EXPIRED MEDICATION

Go in the black can. Make sure to wrap items carefully to prevent them from falling out of the box and to keep them away from children. Never flush medicine down the toilet!

FIRE EXTINGUISHERS

Are accepted by the hazardous waste truck

What to do with ...

as well as the ZAK hazardous waste storage. If possible, please return bottles to the dealer for re-use.

GAS BOTTLES / CARTRIDGES

Are accepted by the hazardous waste truck as well as the ZAK hazardous waste storage. If possible, please return bottles to the dealer for re-use.

GAS RANGES

Will be collected with electrical appliances upon request.

LAWN MOWERS

You can take **gas mowers** to a certified collection point or recycling company recognized according to the End-of-life Vehicle Directive. Lawnmowers that are free of oil and gas can be disposed of at ZAK or with the collection of electronic scrap. **Electric lawnmowers** can be dumped at the recycling centers or, following a request to the Kaiserslautern county administration, will be collected with large electrical appliances. **Manual lawnmowers** are accepted at the recycling centers or collected with bulk waste upon request.

LUMINESCENT TUBES

Are accepted by the hazardous waste truck as well as the ZAK hazardous waste storage.

OLD VEHICLES, CAR WRECKS, CAR PARTS

Must be recycled by certified companies who are recognized according to the End-of-life Vehicle Directive [see Yellow Pages].

OIL TANKS

Must be disposed of by a certified company. Please see the Yellow Pages / business directories for addresses [look for "Tankreinigung"].

PET AND CAT LITTER

Go in the black can.

POTS, DISHES AND CUTLERY

You can take large amounts to the recycling centers in Kindsbach or Kapiteltal. Small amounts go in the black can.

RING BINDERS

Empty ring binders go in the black can.

SANITARY CERAMICS

Such as toilets, bidets, urinals, or sinks can be dumped at the recycling centers in Kindsbach and Kapiteltal.

SLIDES, NEGATIVES, PRIVATE X-RAY IMAGES

Go in the black can.

SYRINGES AND CANNULAS

Must be packed in an impenetrable, firmly closed box and disposed of in the black can.

THERMOMETERS

Mercury thermometers are accepted by the hazardous waste truck. **Digital thermometers** are electronic scrap.

VEHICLE TIRES

Should be returned to the dealer. You can drop-off up to 4 tires (with or without rims) free of charge at the ZAK recycling center.

VIDEO / AUDIO TAPES AND FLOPPY DISKS

Go in the black can.

WALLPAPER

Goes in the black can or the bag for non recyclable waste available from the county. Alternatively, you can take wallpaper to the ZAK recycling center in Kapiteltal.

WASTE OIL

According to the Waste Oil Regulation, dealers of engine and gear oil must take back the amount sold at no cost. Please make use of this opportunity. Household amounts of oil or polluted waste oil as well as oil filters are accepted by the hazardous waste truck or the ZAK hazardous waste storage.
